1. INTRODUCTION

POLE POSITION - Italian Pole Dance Contest is the first Italian competition fully dedicated to performing pole dance while combining all the strands that characterize the discipline: pole sport, exotic pole, contemporary pole, comedy pole. This competition is open to all the amateurs and professionals, Italians and foreigners, that would like to show on stage their own ideals and compete in front of a judge panel varied and competent. It is not necessary to send any video entry to enter the competition, as per point 2.

Major categories will be splat in subcategories, dividing participants upon age/gender criteria as per paragraph 2.

Italian Pole Dance Contest is created and organized by Erika Esposito, owner and CEO of the SSD Female Arts Studio S.r.l. and national responsible for CSEN in Pole Dance field. It is therefore mandatory the affiliation to this sport body in order to be admitted to the competition.

For foreign athletes it won't be possible to issue any insurance coverage by the authority, so copy of personal insurance coverage valid outside origin country must be sent together with the application form.

Italian Pole Dance Contest is a performing competition.

There won't be evaluated only technical competences but, above all, the general performance in all it facets as per paragraph 3 here below.

During the performance it must be used all the space levels and the whole dimensions of the stage.

It will be mandatory to use both poles (static and spin) and the floor of the stage equally, not necessarily breaking down the choreography in 3 parts but trying to distribute the 3 elements (static pole, spin pole and floor work) equally and smoothly.











2. COMPETITION CATEGORIES

Competitors may apply for the following categories, it will be possible to apply for both single and double categories.

Categories "Under 18" and "Under 13" no longer exists, kids/teenagers who would like to compete, should refer to the regulation of the spin-off competition: JUNIORES POLE DANCE CHAMPIONSHIP

Doubles composed by athletes of different categories must choose the highest one. For example: if one of the partners is an "Amateur" and the other one is an "Elite", they will have to apply for "Elite" category.

3. TEAMS

On this year also, Italian Pole Dance Contest will reward the teams who will bring their students.

To join the Teams Competition, each team must send the list of its competitors divided by categories as requested in the appropriate form while sending the filled sheet and attaching the proof of payment for the team registration. Teams must be composed by a minimum of 2 athletes.

Every team must have one contact person, to whom the organization will refer to, to be indicated in the form. He/she or his/her delegate should check-in for the whole team during the rehearsal days or before the beginning of the competition.

Cost of the application fee for each team is € 50,00.

4. AWARDS

At the end of each category there will be rewarded the following awards:

Team rewards will take place at the end of the whole competition. The contact person of each team will have a pass valid for all the duration of the contest and should be present at the final rewards for the receipt of the prize.

5. EVALUATION CRITERIA

Jury panel will be composed by 3 performance judges that will have to evaluate the athlete throughout criteria showed in table 3.A plus 1 deduction judge (head-judge) who, in accordance with the other 3, will deduct penalties as showed in table 3.B. Evaluations will be based on a 0 to 100 score using the following below listed criteria to which will be applied specific deductions:

- Image
- General choreography
- Stage presence
- Tricks difficulty
- Technical execution on the pole
- Technical execution on the floor
- Technical dance execution
- Synchrony (for doubles only)
- Cooperation (for doubles only)
- Originality of the performance

Performance judges will have at disposal the below scheme to help with evaluations, inside every step they'd have a 20 pts range.

HEAD-JUDGE

The head-judge controls the execution of the compulsory elements for the categories Basic, Intermediate and Advanced and is allowed to apply deductions and bonus as per table 3.B.

The compulsory elements will be evaluated with a 50 pts deduction for each element not performed, compulsories must be indicated in the head-judge sheet in the correct execution order and must be the most similar to the proposed images, if a variation is chosen there will be a deduction of 30 pts for incorrect execution.

COMPULSORY ELEMENTS MUST BE KEPT AT LEAST FOR 3 SECS IN ORDER TO ALLOW THE HEAD-JUDGE TO SEE THEM.

The head-judge may assign at his/her own discretion a special bonus for choreographies particularly studied and technically greatly executed.

Penalties will be taken away from the total score of the single performance.

6. MUSIC

It won't be necessary to send the chosen music during the registration, but it will be mandatory to write down the title on the application form. The organization will indicate the piece of music together with the contestant name on the web site of the event in real time while receiving the application.

It isn't allowed to choose the same song already picked by another performer. In case of any duplicates, one of the contestants will be required to change the choice.

Music must be sent by email to info@italianpoledancecontest.com as per deadlines on paragraph 17. Files accepted only in ".mp3" or ".mp4" formats.

Before the sending, rename the file as follow:

In NO way organization will replace the music after the sending.

In case the music won't be sent in due time within the deadlines as stated on paragraph 17, the contestant won't be admitted to the competition and the fee will be kept.

Performances with duration longer or shorter than requested, will face a 10 pts penalty for each judge, the director will inform deduction judge about the timing of the music at the end of the performance. Penalties will be remove from the total sum of points.

We suggest to pick a piece of music which can be considered original and not glorified, the originality in the chosen music is an integral part of the evaluation.

7. COSTUME - HAIRSTYLE - OBJECTS

Performances will be also evaluated at image level, it will therefore be most important details such as costume, hairstyle and make up. A great choreography can be damaged by careless in details, since costume, hairstyle and make up have to be considered as integral part of the choreography itself.

- It is allowed to wear any kind of shoes.
- It is allowed to wear gloves with no grip at choreographic purpose.
- It is allowed to wear gloves with grip only in case of hyper-perspiration pathology confirmed by a doctor; in this case, it will be mandatory to include with the application forms a medical certification stating the pathology.
- It is allowed to wear braces in case of injuries; in this case, it will be mandatory to include to the application form a medical certification stating the pathology.
- It is allowed to wear high-cut culottes, NOT thongs and/or g-strings.
- It is NOT allowed integral nudity and, in case of accidental nudity of any kind, judges may require the immediate interruption of the performance. In this case, the athlete will be allowed to repeat the performance at the end of the category: performance will be evaluated but won't be ranked.
- In case of any mistake on the costume and/or interruption of the performance due to that mistake, the athlete will be allowed to repeat the performance at the end of the category: performance will be evaluated but won't be ranked.
- It is NOT allowed to wear uniforms showing school/studio logos at advertising purpose during the performance on stage; they can be used inside the facility and on the rehearsals, but not during the competition. It isn't allowed to wear costume showing logos and/or pole dance wear brands. Costume and its workmanship will make part of the image score given by the jury. In case of any logos and/or brands showed on the costumes will be deducted 10 pts each judge as penalty.
- It is allowed to bring objects and props on stage, but they may have a sense during the performance and must be utilized/interactive.
- It is allowed to bring set designs on stage in order to create a back ground, scenography cannot be necessary utilized but it will be at the athlete and/or the coach care to deal with its positioning and removing.
- For the contestants in single category it is allowed to bring other persons on stage at performing purpose, unless they won't interact with the technical execution but only acts as a "scenic object".
- It is NOT allowed to bring animals on stage on performing purpose.
- It is NOT allowed to use fire on stage for security reasons.
- It is NOT allowed to use liquids or compounds that may leave the stage sticky and/or slippery in order to avoid to affect the performances which follow.
- It is NOT allowed to use any other aerial tool during the performance, for example: aerial hoops, aerial silks, aerial ropes, etc.

8. REGULATION OF THE SINGLE CATEGORIES

The chose of the category is determined by criteria as per paragraph 3.

Inside each category the athlete must choose 2 compulsory elements among the ones here under proposed.

The chosen tricks must be indicated in the head-judge sheet. The form MUST be dowloaded, duly filled and delivered at the check-in on the competition day directly by the athlete or the coach.

In the Basic category ALL THE INVERSIONS ARE PROHIBITED.

In all the single categories IT IS FORBIDDEN ANY KIND OF ACROBATIC COOPERATIONS with props.



9. PRESENTATION - LIGHTS TECHNICAL SHEET

PRESENTATION: Every choreography will be presented by the director, each athlete could send a presentation of their performance that will be read before the execution. We suggest paying attention while writing the presentation since it will be a great part of the performance itself, especially for the theatrical choreographies.

LIGHTS TECHNICAL SHEETS: Each athlete may choose the atmosphere to be created on stage by the lights technician. Organization won't be able to follow too much detailed sheets, but it will be accepted general indications as per attached forms. "Technical sheet" must be filled on both lights and presentations parts and included with the application form within the deadlines.



11. SPORT INSURANCE

POLE POSITION - Italian Pole Dance Contest Italian Pole Dance Contest is created and organized by SSD Female Arts Studio S.r.l. and Erika Esposito (owner of Female Arts Studio S.r.l. and national responsible for CSEN Pole Dance field). It is therefore mandatory that all the participants to this competition must be affiliated to this sport body on the event dates, both regionals and national.

Starting from this year, insurance and affiliation to CSEN will be included in the application quote.

IT WON'T BE VALID INSURANCES RELEASED BY ANY OTHER SPORT BODIES DIFFERENT FROM CSEN.

For the foreign athletes it won't be possible to issue any insurance coverage by the authority, so copy of personal insurance with coverage valid outside origin country must be sent together with the application forms.

12. APPLICATION FEES

To apply to Italian Pole Dance Contest it's necessary to arrange a bank transfer or PayPal transaction and include a proof of payment together with application documents as indicate in paragraph 16. Here follow the application fees for each category.

13. COACH TICKETS

Coaches will have a free pass if accompanying at least 3 registered athletes granting entrance on the dates of the athletes' competition. In case a coach should have less than 3 athletes performing, an additional fee of € 10,00 for each day will be requested.

The coach ticket will give access as spectator, to the competition field (warm up and preparation) and to the backstage. In any case, the coach must send a written request by email to the organization stating the competitors name and attaching the proof in case of payment.
